Cycling Ireland Proofing Identification and invitation for Garda Vetting Applications

Thank you for agreeing to complete the Garda Vetting process. Before we can invite you to apply for a Garda e-Vetting Form, it is a Garda Vetting requirement that you complete a 100 Point Identification Check. This form must be signed by a responsible person (Step 4) and forwarded along with photocopies of your ID to the authorised Liaison Person in Cycling Ireland once completed. Simply complete this form by following the steps below and an invitation to the e-vetting website will be sent to you on the email address provided in Step 1. Please be aware that this information will be passed to Cycling Ireland and appropriate relevant organisations. You may not take up any role or position requiring vetting until a disclosure has been returned from the National Vetting Bureau of An Garda Síochána and a decision is made by Cycling Ireland on the disclosure returned. Garda Vetting elnvitation and ID Validation Form - how to avoid errors!

- **1.** Ensure your writing is legible please complete the form in **BLOCK** capitals. This is especially important for your email address.
- 2. State what role or position it is that you are being vetted for. E.g. Club Safeguarding Officer, Youth Coach, Youth Leader and Youth Supervisor. Stating 'volunteer' is insufficient information and will not be accepted by the National Vetting Bureau. Please indicate how your role relates to children/vulnerable adults.
- **3. Sign, date** and **tick the box in the Applicant's Declaration**. Use today's date not your date of birth! Do not leave the box unticked!
- 4. Step 4 must be completed by a responsible person prior to sending it in to Cycling Ireland.

 ID documents must be witnessed in person by the signatory. You cannot verify your own ID.
- 5. Photocopies of ID documents must be included with the form. ID documentation must total
 100 points and must include proof of: Full Name Date of Birth Photo ID Current
 Address. Your proof of address must be dated within the past 6 months.
- **6.** Applicant's under the age of 18 will require a Parent/ Guardian consent form. This is available on the Cycling Ireland website.
